#### Basic Life and AD&D:

1 times earnings, rounded to the next higher \$1,000, subject to a maximum of \$100,000.

### **GUARANTEED ISSUE**

Initial eligibility period only

Under age 60: \$100,000

Age 60 but less than age 70: \$100,000

Age 70 and over: none

### **CONTRIBUTION REQUIREMENTS**

Coverage is 100% employer paid.
