Group Supplemental, AD&D and Dependent Life Insurance



City of Grandview

ELIGIBILITY

Employees: You are eligible when actively-at-work on a full-time basis as defined by your employer, except if you are working on a temporary or seasonal basis.

Dependents: You must be insured for your Dependents to be covered.

Dependents are:

- ▶ Your legal spouse who is not legally separated or divorced from you
- ▶ Your legally-recognized domestic or civil union partner
- ▶ Your unmarried financially dependent children* age 1 days to 26 years.

*Natural and adopted children; stepchildren and foster children in your custody.

Also included are your children beyond the limiting age incapable of self-sustaining employment by reason of intellectual disability or physical handicap and chiefly dependent on you for support and maintenance (may vary by state).

For dependents who are confined in a hospital or at home on the date on which they would otherwise become insured, insurance will be effective as of the date the confinement ends.

- ▶ A person may not have coverage as both an Employee and Dependent.
- ▶ Only one insured spouse may cover Dependent children.

BENEFIT REDUCTION DUE TO AGE

(Applicable to employee / spouse coverage)

Age	Original Benefit Reduced to
70	55%
75	30%
80	20%
85	15%

CONTRIBUTION REQUIREMENTS

Supplemental Life:

Coverage is 100% employee paid.

Dependent Life:

Spouse: Coverage is 100% employee paid.

Dependent Child(ren): Coverage is 100% employee paid.

BENEFIT AMOUNT

Supplemental Life:

Choose from a minimum of \$10,000 to a maximum of \$200,000 in \$10,000 increments.

Dependent Life:

Spouse: Choose from a minimum of \$5,000, a maximum of \$100,000 in \$5,000 increments

(spouse amount may not exceed 100% of employee amount)

Dependent Child(ren):

1 days but less than 6 months: \$6,000

6 months through age 26: \$6,000

RATES

GUARANTEED ISSUE

Initial eligibility period only

Employee:

Under age 60: \$100,000

Age 60 but less than age 70: \$50,000

Age 70 and over: \$10,000

Spouse:

Under age 60: \$25,000

Age 60 but less than age 70: \$25,000

Age 70 and over: none

Child: all child amounts are guaranteed issue

For Accidental Loss of	Amount Payable
Life	100%
Two or More Members*	100%
Speech and Hearing	100%
One Member*	50%
Speech or Hearing	50%
Thumb and Index Finger of Same Hand	25%

* "Member" refers to a hand, foot or eye

EXCLUSIONS

LIMITATIONS:

If you or your insured dependent die by suicide, while sane or insane, within one (1) year of your effective date for Supplemental Life and/or Dependent Life insurance coverage, our payment will be limited to a refund of all life insurance premiums paid prior to the date of death.

For a comprehensive list of exclusions and specific limitations, please refer to the Certificate of Insurance. The Certificate also provides all requirements necessary to be eligible for coverage and benefits.
